#### HELPING HANDS INC. HUMANITARIAN ALL NATIONS DIPLOMATIC MISSION (HHIDM) CONSTITUTION

##### Preamble

In accordance with the natural laws of truth and the universal principles of peace, compassion, and sustainability, Helping Hands Inc. Humanitarian All Nations Diplomatic Mission (HHIDM) is hereby constituted as a sovereign humanitarian diplomatic mission guided by the Vienna Convention on Diplomatic Relations (1961) and the Vienna Convention on Consular Relations (1963).

HHIDM stands as a lawful diplomatic body dedicated to global peace, humanitarian service, environmental preservation, education, and the upliftment of all beings without discrimination.

##### **Article I – Foundation and Authority**

1. HHIDM derives its authority from the Declaration of Formation adopted by its Founding Cabinet.
2. The Head of the Governing Body, serving as the Honorable Minister of Peace, holds supreme executive authority to sign, implement, and oversee all diplomatic, administrative, and financial functions in accordance with HHIDM laws.
3. All laws passed by the Cabinet shall come into force upon the signature of the Honorable Minister of Peace.

##### **Article II – Cabinet and Governance**

1. The Cabinet consists of seven members holding multiple portfolios for effective governance.

2. The Cabinet acts collectively in legislative and administrative matters, under the guidance and approval of the Head of the Governing Body.

3. All Cabinet actions and resolutions are recorded as instruments of HHIDM law.

### **Article III – Legal Standing**

1. HHIDM functions as a diplomatic mission under the laws of sovereignty and self-governance as recognized under international law.

2. All bilateral treaties and agreements executed by HHIDM are binding under the authority of the Head of the Governing Body and Cabinet approval.

### **Article IV – Humanitarian and Sustainable Mission**

1. HHIDM shall promote sustainable projects in education, healthcare, organic agriculture, eco-housing, and cultural restoration.

2. All actions of HHIDM shall adhere to universal truth and the law of non-harm toward all living beings.

**This Constitution of Helping Hands Inc. Humanitarian All Nations Diplomatic Mission (HHIDM) was adopted in the year 2000 and fully implemented by 2017 under the authority of the Head of the Governing Body and the Cabinet of HHIDM.**

### **Certification**

This Constitution is hereby affirmed as the official and governing instrument of Helping Hands Inc. Humanitarian All Nations Diplomatic Mission (HHIDM).
